GENERAL RULES & REGULATIONS AND CONSENT FOR THE PROCESSING OF PERSONAL DATA

1. The right to admission in the B.N.P.S. Sports Academy is reserved with B.N.P.S. Sports Academy & Bharat National Public School.
2. No entry with out proper id card issued by B.N.P.S. Sports Academy (players/parents).
3. All fees & registration charges paid to B.N.P.S. Sports Academy are non-refundable & non – transferable. Registration is done on annual basis & it should be renewed accordingly.
4. Monthly fees are subject to increase based on the needs/requirement of the B.N.P.S. Sports Academy on annual basis.
5. Coaching Session starts from beginning of each month till end of each month. Coaching Fees should be deposited before 10th of every month, failing which Rs50/- per coaching session will be charged as late fee along with the monthly fee.
6. Trainee attending extra classes will be charged full or half-month fees accordingly and in case of non - payment for a particular month without payment, their admission will be canceled.
7. Players must carry all the time the I-Card issued to them and in case of loss of I – Card please immediately intimate to the concerned authority. Fresh I – Card will be issued at a cost of Rs. 50/-.
- 8. Parents are not allowed in the Academy during coaching hours & have to pick their children from the main gate of Academy once the coaching gets over.**
9. All the players will have to adhere to the scheduled timings and maintain the discipline of the B.N.P.S. Sports Academy.
10. During coaching session all the players must be in proper sports gear in accordance with the sport.
11. For practice matches, a fee will be charged (which include ground booking charges, travelling expenses & refreshment).
12. Criteria for selecting a player in the team is purely based on overall performance of the player i.e., attendance, behaviour, fitness, game sense.
13. Sports may periodically photograph activities at the facility that may result in photographs of patrons that later appear in promotional materials. By entering B.N.P.S. Sports Academy you are consenting to being photographed while in the facility.

16. Players must take care of their belongings. In case of any loss/ damage, the B.N.P.S. Sports Academy / School authorities shall not be responsible for it.

BEHAVIOR/CONDUCT

17. No discourteous behavior, arguing with officials or employees of B.N.P.S. Sports Academy or flagrant violations of any rules of a game or other activity shall be permitted by any participant in an activity at B.N.P.S. Sports Academy. Subject to any rules specific to each sport, any participant arguing with an official may, at the sole discretion of B.N.P.S. Sports Academy or any official, be precluded from finishing the game (i.e., ejected). Any ejection as warranted under any rule or regulation set forth herein shall be followed by an immediate one-day suspension to occur on the next date that the participant is scheduled to participate in a game at B.N.P.S. Sports Academy.

18. No discourteous behavior or arguing with officials or employees of B.N.P.S. Sports Academy shall be permitted by any fan, visitor, patron or other person entering B.N.P.S. Sports Academy. At the sole and reasonable discretion of B.N.P.S. Sports Academy or any official, a person shall be precluded or denied further access to or from B.N.P.S. Sports Academy due to such improper conduct.
